## Summary

Keeping your personal data safe is very important to us. This privacy notice will inform you of how we look after your personal data, tell you about your privacy rights and how to exercise your rights under legislation.

Your personal data is stored securely at all times, in our clinical systems. Only authorised individuals who need access for the legal circumstances set out in the sections below can access your personal data.

We may share information about you with other General Practices (GPs), NHS acute or mental health Trusts, community health providers, pharmacists, ambulance services, social services, and NHS commissioning organisations who are directly involved in providing or funding your care needs and for the purpose of indirect care (see secondary uses below). Your data will not be shared with anyone who is not listed in this privacy notice unless we are obliged by law.

We **do not** share your personal information with marketing and advertising companies, and we do not share your data with anyone who would take your data outside of the UK (GDPR) jurisdiction.

We will only share personal information about you with medical research organisations with your consent or as described in the section below, and you have the right to withdraw your consent at any time by contacting the Practice/Service you are registered with. The national data opt-out allows people to opt out of their confidential information being used for research and planning. You can read more about it on the [NHS.uk](https://www.nhs.uk) website.

## 1. Who we are

Operose Health is the trading name used by a number of companies providing NHS primary care and community healthcare services across England. The organisation responsible for your personal information (the Data Controller) will be the Operose Health practice or service providing your care.

## 2. What we do

At Operose Health, we are experts in working with complex health systems to provide the very best healthcare service to our patients and services users, and to transform their quality of healthcare experience. We are part of a global healthcare family with over 30 years' experience of delivering high quality healthcare in the most simple and seamless way to our patients and service users, and we are committed to protecting and respecting their privacy.

Our portfolio of services includes primary care, community outpatient services and referral management services. We respect your right with regards to privacy and data protection when you communicate with us through our websites, events, telephone, or attend any of our face-to-face consultation services.

Your personal data is stored in our secure clinical systems, only those who are involved in delivering your care have access to your personal data. Your data will not be shared with anyone else, unless we are obliged by law.

### 2A – Call Recording and Communication Systems

Call recordings may form part of the patient's healthcare record where relevant to the provision of care, investigation of incidents, complaints handling or safeguarding matters. To support patient safety, service improvement, staff training, quality monitoring, complaint investigation and regulatory requirements, telephone calls and other communications with our services may be recorded.

Recordings are stored securely and access is restricted to authorised personnel with a legitimate business need.

Recordings will only be accessed where there is a lawful reason to do so, including:

- Investigating complaints.
- Reviewing incidents.
- Supporting staff training.
- Monitoring service quality.
- Meeting regulatory or legal obligations.

Recordings are retained in accordance with the NHS Records Management Code of Practice and applicable retention schedules.

### 2B – Dr iQ and Digital Services

Operose Health offers access to certain services through digital platforms, including Dr iQ and other approved patient engagement systems.

Where you use these services, personal information may be collected and processed to:

- Book or manage appointments.
- Submit medical queries or requests.
- Request repeat prescriptions.
- Communicate with healthcare professionals.
- Access information relating to your care.

Information submitted through these systems forms part of your healthcare record where appropriate and is processed in accordance with this Privacy Notice.

## 2C – Artificial Intelligence (AI)

Operose Health may use approved Artificial Intelligence (AI) technologies to support the delivery of healthcare services, improve administrative efficiency, assist with clinical documentation and enhance patient access to services.

Any AI tools used by Operose Health are subject to appropriate governance, security, confidentiality and clinical safety requirements.

AI technologies support healthcare professionals and do not replace professional clinical judgement. No decisions about a patient's care are made solely by automated means that would produce legal or similarly significant effects.

Where AI technologies process personal information, this will be carried out in accordance with UK GDPR, the Data Protection Act 2018, NHS guidance and applicable clinical safety standards.

## 3. Sharing your personal information

We may share information about you with other General Practices (GPs), NHS acute or mental health Trusts, community health providers, pharmacists, ambulance services, social services, and NHS commissioning organisations who are directly involved in providing or funding your care needs or for the purpose of indirect care (see secondary uses below). Your data will not be shared with anyone else, unless we are obliged by law.

We **do not** share your personal information with marketing and advertising companies. We take appropriate measures to ensure that personal information is processed securely and in accordance with UK data protection legislation. Where information is processed outside the UK, appropriate safeguards will be implemented in accordance with UK GDPR requirements.

We will only share personal information about you with medical research organisations with your explicit consent, and you have the right to withdraw your consent at any time.

A full list of the organisations we share information with, and why, is provided in the later section of this Privacy Notice.

## 4. What is this Privacy Notice about?

A privacy notice is a statement that describes how an organisation collects, uses, retains and discloses personal data, or special categories of personal data. Different organisations sometimes use different terms, and it can be referred to as a privacy statement, a fair processing notice or a privacy policy.

Being transparent and providing accessible information to individuals about how an organisation will use their personal information is a key element of the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018. To ensure that we process your personal data fairly, lawfully and transparently we are required by law to provide you with the following information:

- What information we collect and process about you
- How we process your personal data

- The purpose of processing
- Recipients or categories of recipients of your personal data
- The identity of our Data Protection Officer
- How long we retain personal information about you
- The lawful bases for processing
- Your rights - to view, request access copies of your personal information, or object to the processing of your personal information.

## 5. Types of personal information we process

At Operose Health, we process the following categories of personal information about our patients and service users:

Category	Data Type
Identity data and contact details	Such as name, date of birth, gender, NHS number, telephone number, postal address, postcode, email address (if provided) etc.
Support contact details	Names, contact details of carers, relevant close relatives, next of kin and representatives
Special categories of personal data concerning physical, social or mental health condition.	Such as medical history, diagnosis, treatments, test results, appointment, attendances, referrals, care plans, care packages, medication, medical opinions etc.
Special categories of personal with protected characteristics	Such as racial or ethnic origin, religious or philosophical beliefs, genetic data, sexual life or sexual orientation data, child protection records, adoption records etc.
Aggregated data	A combination of personal data, and special categories of personal data for the purpose of business intelligence and analytical services to enable us to predict future trends and plan our services.
Usage data	Our websites use cookies to distinguish you from other user when you access our online services. A cookie is a small file of letters and numbers that we store on your browser when you consent to use of our online services. This helps us to provide you with a good experience when you browse our site and enable us to improve our site. Usage data may include interactions with digital consultation systems, patient portals, appointment booking services and online healthcare applications.

## 6. What we process your personal information for

We process personal information about you in a number of ways. These include:

**Primary uses** – we process personal information concerning your health to enable our registered and regulated healthcare professionals who are directly involved in your care to provide you with the best possible direct care delivery.

Personal information concerning your health or social care is also made available to other health or social care provider organisations who are involved in your health or social care needs to enable them to make the best-informed decision about you when you use their service.

**Secondary uses** – We process your personal information for purposes of beyond direct care in the following ways:

- Reviewing the care we provide through clinical audit.
- Investigating your queries, complaints and legal claims.
- Ensuring we receive payment for the healthcare you receive.
- Preparing statistics on NHS performance.
- Auditing NHS accounts and services.
- Undertaking health research and development where appropriate legal permissions exist, including where consent is required or where another lawful basis applies.
- For business intelligence and analytical services to enable us to predict future trends and plan our services.
- Training and educating our healthcare professionals (with your explicit consent, and you have the right choose whether or not to be involved).

## **6A – Common Law Duty of Confidentiality**

In addition to our obligations under UK GDPR and the Data Protection Act 2018, we comply with the Common Law Duty of Confidentiality.

Information provided in confidence will normally only be used for your direct care unless:

- You have provided consent;
- There is a legal requirement to disclose information;
- Disclosure is necessary to protect you or others from serious harm; or
- There is another lawful basis permitting disclosure.

## **6B – Lawful Basis for Processing**

Operose Health processes personal information in accordance with the UK General Data Protection Regulation (UK GDPR), the Data Protection Act 2018, the Common Law Duty of Confidentiality, and other applicable health and social care legislation.

The specific lawful basis relied upon for each processing activity is set out throughout this Privacy Notice and within the information-sharing tables below. Depending on the purpose of processing, Operose Health may rely on one or more of the following lawful bases:

### **Article 6 UK GDPR (Personal Data)**

- Article 6(1)(e) – Public Task  
Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in Operose Health.
- Article 6(1)(c) – Legal Obligation  
Processing is necessary for compliance with a legal obligation to which Operose Health is subject.
- Article 6(1)(d) – Vital Interests  
Processing is necessary to protect the vital interests of an individual, particularly in emergency situations.
- Article 6(1)(a) – Consent  
Where consent is required, processing will only take place with the individual's freely given, specific, informed and unambiguous consent.

### **Article 9 UK GDPR (Special Category Data)**

As healthcare providers, we routinely process special category personal data relating to health. This processing may be carried out under one or more of the following conditions:

- Article 9(2)(h) – Health and Social Care  
Processing is necessary for the provision of health or social care, medical diagnosis, treatment, or the management of health and social care systems and services.
- Article 9(2)(i) – Public Health  
Processing is necessary for reasons of public interest in the area of public health.
- Article 9(2)(g) – Substantial Public Interest  
Processing is necessary for reasons of substantial public interest where permitted by law.
- Article 9(2)(f) – Legal Claims  
Processing is necessary for the establishment, exercise or defence of legal claims.
- Article 9(2)(j) – Research and Statistical Purposes  
Processing is necessary for scientific or historical research purposes, statistical purposes or archiving purposes in the public interest, subject to appropriate safeguards.

Further information regarding the lawful basis applicable to specific processing activities can be found throughout this Privacy Notice, including within the sections relating to direct care, statutory disclosures, commissioning, research, data sharing and approved service providers.

## 10. Details of data linkage with other datasets

Data may be de-identified and linked so that it can be used to improve health care and development and monitor NHS performance. Where data is used for statistical purposes, stringent measures are taken to ensure individual patients cannot be identified.

When analysing current health services and proposals for developing future services it is sometimes necessary to link separate individual datasets to be able to produce a comprehensive evaluation. This may involve linking primary care GP data with other data such as secondary uses service (SUS) data (inpatient, outpatient and A&E). In some cases, there may also be a need to link local datasets which could include a range of acute-based services such as radiology, physiotherapy, audiology etc, as well as mental health and community-based services such as Improving Access to Psychological Therapies (IAPT), community nursing, podiatry etc. When carrying out this analysis, the linkage of these datasets is always done using a unique identifier that does not reveal a person's identity.

Integrated Care Boards within our geographical areas are responsible for processing de-identified and linked data under this category, on our behalf. We ensure that the Processor is legally and contractually bound to operate and prove security arrangements are in place where data that could or does identify a person are processed.

## 11. Data retention period

All records held by Operose Health are retained in accordance with the NHS Records Management Code of Practice for Health and Social Care 2021 and supplemented by Operose Health's Records Management Standards and retention schedules.

We will only retain your personal data for as long as necessary to fulfil the purposes for which it was collected, including to meet legal, regulatory, contractual, clinical, operational and reporting requirements.

When determining the appropriate retention period, we consider:

- The nature, category and sensitivity of the personal data;
- The potential risk of harm arising from unauthorised use or disclosure;
- The purposes for which the personal data is processed and whether those purposes can be achieved by other means;
- Applicable legal, regulatory and professional requirements; and
- NHS retention requirements and guidance.

Further information regarding specific retention periods can be provided upon request.

## 12. The details of transfers of personal data to any third countries or international organisations

Operose Health seeks to ensure that personal information is processed and stored within the United Kingdom wherever possible.

In some circumstances, personal information may be processed by approved suppliers or service providers who utilise systems, infrastructure or support services located outside the United Kingdom. Where this occurs, appropriate safeguards will be implemented in

accordance with UK GDPR and the Data Protection Act 2018 to ensure that personal information remains protected and that an equivalent level of protection is maintained.

Where international transfers occur, these will be undertaken only where there is a lawful basis to do so and appropriate contractual, technical and organisational safeguards are in place.

### **13. What safeguards are in place to ensure data that identifies you are secure?**

We only process information that may identify you in accordance with the UK General Data Protection Regulation (UK GDPR), the Data Protection Act 2018, the Common Law Duty of Confidentiality and other applicable health and social care legislation. These legal frameworks require us to ensure that personal information is processed lawfully, fairly and transparently.

We take the security of your personal information seriously and have implemented appropriate technical and organisational measures to protect it against unauthorised access, alteration, disclosure, loss or destruction.

We ensure that:

- Personal information is stored in secure systems and locations.
- Access to personal information is restricted to authorised personnel who require access to perform their duties.
- Personal and confidential information stored on devices such as laptops and mobile devices is protected through encryption and other security controls.
- Staff receive appropriate information governance, data protection and cyber security training.

Our technical and organisational security measures include:

- Measures to ensure the ongoing confidentiality, integrity, availability and resilience of our systems and services.
- The ability to restore the availability of and access to personal information in a timely manner following a physical or technical incident.
- Regular testing, assessment and evaluation of the effectiveness of our security measures, including compliance with the principles of privacy by design and privacy by default.
- Encryption technologies.
- Firewalls, Virtual Private Networks (VPNs) and secure network controls.
- Password-protected systems and files.
- Role-based access controls and restricted access folders.
- System monitoring, audit logging and security reviews.

### **14. Cookies**

Our websites use cookies to distinguish you from other user when you access our online services. A cookie is a small file of letters and numbers that we store on your browser when you consent to use of our online services. This helps us to provide you with a good experience when you browse our site and enable us to improve our websites.

**We use the following cookies:**

- **Strictly necessary cookies:** These are cookies that are required for the operation of our site. They include, for example, cookies that enable you to login to secure areas of our websites.
- **Analytical/performance cookies.** They allow us to recognise and count the number of visitors and to see how visitors move around our site when they are using it. This helps us to improve the way our websites work, for example, by ensuring that users are finding what they are looking for easily.
- **Functionality cookies.** These are used to recognise you when you return to our site. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region).
- **Targeting cookies.** These cookies record your visit to our site, the pages you have visited and the links you have followed. We will use this information to make our site more relevant to your interests. We may also share this information with third parties for this purpose.

You can block cookies by activating the setting on your browser that allows you to refuse the setting of all or some cookies. However, if you use your browser settings to block all cookies (including essential cookies) you may not be able to access all or parts of our site.

Except for essential cookies, all cookies will expire after 12 months.

## 15. What are your general rights?

Where information from which you can be identified is held, you have the:

- Right of access to view or request copies of the record
- Right to rectification of inaccurate personal data or special categories of personal data
- Right to restriction of the processing of your data where accuracy of the data is contested, processing is unlawful or where we no longer need the data for the purposes of the processing
- Right not to be subject to any automated individual decision-making
- Right to data portability by requesting the data which you provided to us (not data generated by us) in a structured, commonly used machine-readable format. Your right to portability shall apply only where:
  - data is processed by automated means, and
  - you provided consent to the processing or,
  - the processing is necessary for the fulfilment of a contract.

## 16. Right to object

In line with the Data Protection Legislation, you do not have the right to object to the processing of your personal information where:

- The purpose of the processing is for direct provision of care or safeguarding concerns. As a primary care and community health provider, we have legitimate compelling grounds under the Health and Social Care Act 2012 to process your personal information for the purposes of direct care delivery, and to prevent an individual from harm, or to prevent a serious crime. This include personal information concerning your health which we share with other GP Practices, NHS acute or mental health Trusts, social services, community health providers and pharmacists who are also involved in your care.

- The processing is necessary for compliance with a legal obligation to which we are subject. This includes information we share with statutory organisations, law enforcement and regulatory bodies such as NHS Digital (statutory data collection), NHS Counter Fraud, the Police, Courts of Justice, HMRC and DVLA.

**You do not have the right to object** to the processing of your personal information for risk stratification for indirect care purpose such as understanding the local population needs and plan for future requirement in line with [Section 251 NHS Act 2006](#) .

#### **17. Right to erasure (right to be forgotten)**

Your right to erasure (right to be forgotten) applies where you had given ‘consent’ to process your personal data and later withdrew the consent. Right to erasure does not apply to the extent where the processing of your personal health data is necessary for:

- Compliance with a legal obligation which we are subject to, under the UK law or, for the performance of a task carried out in the public interest or, in the exercise of official authority vested on us;
  - medical purposes and/or for reasons of public interest in the area of public health; archiving purposes in the public interest, scientific or historical research purposes or statistical purposes;
- the establishment, exercise or defense of legal claims.

#### **18. Exercising your right or gaining access to the data we hold about you**

By contacting your registered practice, you can exercise your rights at any time, or request to see or have copies of personal information we hold about you.

#### **19. Right to complain**
